3	programs and services designed to meet their special needs; and					
4	WHEREAS, the Tohono O'odham Legislative Council is desirous to continue to provide Child Care					
5	Services to its young tribal members; and					
6	WHEREAS, the Department of Health and Human Services, Administration for Children and					
7	Families has awarded the Tohono O'Odham Nation the Child Care & Development					
8	Fund, totaling \$1,082,560.00 to implement a Child Care Services Program through the					
9	Division of Early Childhood Development; and					
10	WHEREAS, the Child Care & Development Fund is a multi-year grant in which funding may be					
11	utilized within a two year period to obligate funds and a third year to liquidate funds;					
12	and					
13	WHEREAS, the Division of Early Childhood Development of the Tohono O'odham Nation has					
14	submitted for review and approval the proposed Child Care & Development Fund for					
15	Grant Year 2002.					
16	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Nation Legislative Council					
17	does hereby approve the Child Care & Development Fund budget for:					
18	Grant Year 2002 - Discretionary Funds for Administrative Cost in the amount of					
19	\$75,643.46; and					
20	Grant Year 2002 - Discretionary Funds for Program Cost in the amount of \$335,800.54;					
21	and					
22	Grant Year 2002 - Mandatory Funds for Administrative Cost in the amount of					
23	\$52,958.88; and					
24	Grant Year 2002 - Mandatory Funds for Program Cost in the amount of \$618,157.12.					
25	BE IT FURTHER RESOLVED that the duration of this budget would be from October 01, 2001					
26	to September 30, 2002.					
27	BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'Odham

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the <u>20<sup>th</sup>.</u> Day of DECEMBER, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-AGAINST; -0-NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (f)) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
