1 **WHEREAS, the Tohono O'odham Nation has always had a desire to provide for health and welfare**  
2 **needs of O'odham children and families; and**

3 **WHEREAS, the Tohono O'odham Department of Human Services/Child Welfare Services has the**  
4 **primary responsibility to provide for those families found to be in the need of such**  
5 **care; and**

6 **WHEREAS, the Title IV-B, Subpart 1 and Subpart 2 of the Social Security Act provides funds for**  
7 **development of a five year plan for demonstrating effective prevention approaches for**  
8 **handling increasing family problems/dysfunction under specified terms and**  
9 **conditions; and**

10 **WHEREAS, the Title IV-B, Subpart 1 and Subpart 2 of the Social Security Act provides funds for**  
11 **development of a five year plan for demonstrating effective prevention approaches**  
12 **for handling increasing family problems/dysfunction under specified terms and**  
13 **conditions; and**

14 **WHEREAS, in FY 2000 a five year plan was submitted by the Human Services/Child Welfare**  
15 **Division and the second year budget covering from October 01, 2001 to September 30,**  
16 **2002 is hereby submitted for review and approval; and**

17 **WHEREAS, Title IV-B, Subpart 1 and Subpart 2 requires yearly re-application for funds to support**  
18 **the five year plan.**

19 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 20           **1. It does approve the FY 2002 Title IV-B application funding in the amount of**  
21           **\$46,047.00 for Subpart 1.**
- 22           **2. The budget period is FY 02 (October 01, 2001 to September 30, 2002).**
- 23           **3. The Tohono O'odham Nation's Officials, to wit, the Chairman is hereby**  
24           **authorized to negotiate and execute the budget.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20<sup>th</sup> Day**  
26 **of DECEMBER, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-**  
27 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section**  
28 **1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
29 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
30 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
31 **Stat. 984).**
