

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 2002 Elderly Title III Grant Amendment July 01, 2001 - June 30, 2002)**

RESOLUTION NO. 01-647

1 **WHEREAS, the Tohono O'odham Nation has successfully operated a program for the elderly**
2 **members of the Nation; and**

3 **WHEREAS, funding for the operation of the Elderly Program has been made possible in part by**
4 **Title III of the Older Americans Act of 1965 as amended, through the Administration**
5 **of the Inter-Tribal Council of Arizona (ITCA); and**

6 **WHEREAS, the services provided to elderly members have been beneficial and services continue**
7 **to be necessary to provide nutritional and social support; and**

8 **WHEREAS, ITCA has made additional funds available in the amount of \$25,305 for a Family**
9 **Caregiver Support Program (F.C.S.P.) For FY 2002.**

10 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council:**

- 11 **1. That it hereby approves the Title III Grant Amendment increase of \$25,305.00 for**
12 **FY 2002 to be spent in accordance with the attached budget.**
- 13 **2. That the Nation has been informed by Inter-Tribal Council on Aging that the**
14 **budget period for FY 2002 F.C.S.P. will be from July 01, 2001 through June 30, 2002.**
- 15 **3. That the Tohono O'odham Nation officials, to wit: The Chairman is hereby**
16 **authorized to negotiate and execute the grant, provided however, that any**
17 **amendments affecting the funding or funding levels of this contract shall be**
18 **submitted for further prior approval by this Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH, Day**
20 **of DECEMBER, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-**
21 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
22 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
23 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
25 **Stat. 984).**


