3	WHEREAS, the funding for the Tohono O'odham Nation Tribal Employment Rights Office has been
4	supplemented by the Equal Employment Opportunity Commission in the amount of
5	\$25,000.00; and
6	WHEREAS, the continued operation of the Tribal Employment Rights Office is essential to
7	eradicate employment discrimination within the exterior boundaries of the Tohono
8	O'odham Nation; and
9	WHEREAS, the contract between the Equal Employment Opportunity Commission and the Tohono
10	O'odham Tribal Employment Rights Office has been approved by the Office of the
11	Chairman in the amount of \$25,000.00.
12	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Nation Legislative Council that it
13	hereby approves the continued supplemental funding for the Tribal Employment
14	Rights Office from the Equal Employment Opportunity Commission in the amount of
15	\$25,000.00.
16	BE IT FURTHER RESOLVED that the duration of this grant shall commence on October 01, 2001
17	through September 30, 2002.
18	BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono
19	O'odham Nation's officials, to wit: the Chairman is authorized to negotiate and execute
20	the grant, provided however, that any amendments affecting the funding, or funding
21	levels of the grant shall be submitted for further prior approval by this Council.
