9	01, 2001 through September 30, 2002) in the amount of \$152,966.14.							
10	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council:							
11	1. That it hereby approves FY 2002 ALTCS budget from October 01, 2001 to							
12	September 30, 2002.							
13	2. That the Tohono O'odham Nation's officials to wit: the Chairman and any							
14	designated official are hereby authorized to negotiate and execute the grant,							
15	provided however, that any amendment affecting the funding or funding levels							
16		of this contract shall be submitted for further prior approval by this Council.
