

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of FY 2002 Department of Human Services/Division of Community Health Services - Elder Health Care Initiative Budget Modification #1)

RESOLUTION NO. 01-650

1 **WHEREAS, the Tohono O'odham Nation is presently developing a Home Health Agency under IHS**
2 **Grant #ISH002103-02 with the Indian Health Services; and**

3 **WHEREAS, the Tohono O'odham Nation through Legislative Council Resolution No. 01-482,**
4 **approved a five (5) year project and year five budget in the amount of \$176,868.00; and**

5 **WHEREAS, due to a decrease in fringe benefits from 32% to 30% a budget modification is**
6 **submitted for review and approval.**

7 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 8 **1. It hereby approves the submission of the Elder Health Care Initiative Budget**
9 **Modification #1, as submitted.**
- 10 **2. The Tohono O'odham Nation Officials, to wit: the Chairman is hereby authorized**
11 **to negotiate and execute contracts associated with this grant and to expend funds**
12 **when received.**

13 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH Day**
14 **of DECEMBER, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-**
15 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
16 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
17 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
18 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
19 **Stat. 984).**
