

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of FY 2002 Department of Human Services/Division of Community Health
Services - Home Health Third Party Revenue Budget)

RESOLUTION NO. 01-651

1 **WHEREAS, the Tohono O'odham Nation has a Home Health Agency that was developed under IHS**
2 **Grant #ISH002103-02 with the Indian Health Services; and**

3 **WHEREAS, the Legislative Council, through Resolution No. 98-501, established a new Special**
4 **Revenue Fund and budget for additional Personnel and Operational expenditures**
5 **utilizing third party revenues; and**

6 **WHEREAS, the Legislative Council through Resolution No. 98-501 authorized that unspent home**
7 **health third party revenues, in any given fiscal year, to be carried over to the next**
8 **fiscal year's Home Health Third Party Revenue Budget; and**


9 **WHEREAS, a home health third party revenue budget for FY 2002 is submitted for review and**
10 **approval.**

11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 12 **1. It hereby approves the FY 2002 Home Health third party revenue budget as**
13 **proposed.**
- 14 **2. It hereby authorizes, that unspent home health third party revenues, in any given**
15 **fiscal year, to be carried over to the next fiscal year's Home Health Third Party**
16 **Revenue Budget.**
- 17 **3. The Tohono O'odham Nation Officials, to wit: the Chairman is hereby authorized**
18 **to negotiate and execute contracts and expend funds when received.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH Day**
20 **of DECEMBER, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-**
21 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
22 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
23 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
25 **Stat. 984).**




