

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of FY 2002 Department of Human Services - Division of Health
Transportation Services Third Party Revenue Budget)

RESOLUTION NO. 01-652

1 **WHEREAS, the Tohono O'odham Nation is currently providing medically necessary**
2 **transportation to members and residents of the Nation, collecting any and all third**
3 **party reimbursements where applicable; and**

4 **WHEREAS, there is a need to budget FY 2002 Third Party revenue funds to cover the operational**
5 **costs of Health Transportation Services Division; and**

6 **WHEREAS, the Department of Human Services has submitted a budget which reauthorizes to**
7 **carry forward \$451,652.30 from FY 2001 to FY 2002 to establish a Capital Equipment**
8 **line item to cover the cost of vans, wheelchairs and a fax machine; and**

9 **WHEREAS, the Legislative Council through Resolution No. 2000-258 approved that all third party**
10 **reimbursement funds obtained by the Division of Health Transportation Services be**
11 **applied to the program's base budget and utilized for program operations; and**

12 **WHEREAS, the Division of Health Transportation Services has sufficient funds deposited with the**
13 **Nation's Accounting Department to cover the proposed budget amount of \$451,652.30;**
14 **and**

15 **WHEREAS, a Third Party Revenue budget for FY 2002 has been submitted for review and approval**
16 **by the Department of Human Services for the Division of Health Transportation**
17 **Services.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
19 **approves:**

- 20 **1. The attached Third Party Revenue budget as submitted to supplement the FY 2002**
21 **Health Transportation Services base budget.**
- 22 **2. The reauthorization to carry forward \$451,652.30 from FY 2001 to FY 2002 to**
23 **establish a Capital Equipment line item to cover the cost to purchase three (3)**
24 **wheelchair vans, wheelchairs and a fax machine for the Division of Health**
25 **Transportation Services.**
- 26 **3. The Tohono O'odham Nation Officials, to wit: the Chairman and Vice Chairman**
27 **and any designated Official is hereby authorized to negotiate and execute**
28 **contracts and expend funds associated with this budget.**

6 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
7 Stat. 984).
