10		reimbursement funds obtained by the Division of Health Transportation Services be
11		applied to the program's base budget and utilized for program operations; and
12	WHEREAS,	$the\ Division\ of\ Health\ Transportation\ Services\ has\ sufficient\ funds\ deposited\ with\ the$
13		Nation's Accounting Department to cover the proposed budget amount of \$451,652.30;
