1 **WHEREAS, the Water Resources Study Program of the Natural Resources Department was**
2 **awarded a Clean Water Act Section 106 grant for water quality planning and**
3 **management in the amount of \$150,000.00, and Resolution No. 01-244; and**


4 **WHEREAS, the Water Resources Study Program has proposed a budget amendment in fiscal year**
5 **2002 in the amount of \$150,000.00 to augment its budget line items for salaries and**
6 **fringe benefits; and**

7 **WHEREAS, this budget amendment has been reviewed by the Water Resources Committee and the**
8 **Budget and Finance Committee and is recommended for approval by the Legislative**
9 **Council.**

10 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that the total**
11 **budget amendment funding for Fiscal Year 2002 of \$150,000.00 for the Water**
12 **Resources Study Program is approved in accordance with the budget amendment**
13 **attached hereto.**

14 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH Day**
15 **of DECEMBER, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-**
16 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
17 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
18 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
19 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
20 **Stat. 984).**
