2 **Healthy O'odham Promotion Program Fiscal Year 2002 budget; and**

3 **WHEREAS, the Healthy O'odham Promotion Program is requesting to modify its Fiscal Year 2002**

4 **budget to reflect adjustments made by the Valiant Employee Compensation Study; and**

5 **WHEREAS, the Healthy O'odham Promotion Program is requesting to modify its FY 2002 budget**

6 **to add vehicle operations line items; and**

7 **WHEREAS, in adding vehicle operations line items to budget 11-1453, the Healthy O'odham**

8 **Program closes tribal budget number 01-1453.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**

10 **Healthy O'odham Promotion Program FY 2002 Budget Modification Number 1.**

11 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH. Day**
12 **of DECEMBER, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-**
13 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
14 **Section 1 (d)(3) and (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**
15 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
16 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
17 **18, 1934 (48 Stat. 984).**
