

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of FY 2002 Elderly Title VI Program Budget Amendment #1/Modification #1)**

**RESOLUTION NO. 01-658**

1 **WHEREAS, the Tohono O'odham Nation has successfully operated a program for the elderly**  
2 **members of the Nation; and**

3 **WHEREAS, funding for the operation of the Elderly Program has been made possible in part by**  
4 **Title VI of the Older Americans Act of 1978, as amended; and**

5 **WHEREAS, the Elderly Program received a total grant award of \$128,550.00, an increase of**  
6 **\$27,590.00 and hereby amends the original budget to include the increase; and**

7 **WHEREAS, previous year carryover funds of \$42,223.70 is also included in amendment to increase**  
8 **funding in the operational line items; and**

9 **WHEREAS, the budget modification also reflects salaries and fringe adjustments and transferring**  
10 **of any savings to the operational line items.**

11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
12 **approves:**

- 13 **1. The FY 2002 Title VI budget amendment/modification #1.**
- 14 **2. The Tohono O'odham Nation's officials, to wit: The Chairman and Vice Chairman**  
15 **or designated official are hereby authorized to negotiate and execute the grant**  
16 **and expend funds per attached budget, provided however, that any amendments**  
17 **affecting the funding or funding levels of this contract shall be submitted for**  
18 **further prior approval by this Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20<sup>TH</sup> Day**  
20 **of DECEMBER, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-**  
21 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
22 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
23 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
25 **Stat. 984).**






