

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 2002 Approval of Senior Services Division Title III C-1 Budget Modification #1)**

RESOLUTION NO. 01-660

1 **WHEREAS, the Tohono O'odham Nation has successfully operated a program for the elderly**
2 **members of the Nation; and**

3 **WHEREAS, funding for the operation of the Elderly Program has been made possible in part by**
4 **Title III C-1 of the Older Americans Act of 1965 as amended, through the**
5 **Administration of the Inter-Tribal Council of Arizona (I.T.C.A.); and**


6 **WHEREAS, the Division of Senior Services budget modification Title III C-1 adds to the line items**
7 **of salary and fringe benefits for the Senior Services Manager position.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:**

- 9 **1. Approves and authorizes the budget modification of Senior Services Division Title**
10 **III C-1 as attached.**
- 11 **2. The Tohono O'odham Nation officials, to wit: The Chairman is hereby authorized**
12 **to negotiate and execute the grant, provided however, that any amendments**
13 **affecting the funding or funding levels of this contract shall be submitted for**
14 **further prior approval by this Council.**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH Day**
16 **of DECEMBER, 2001 at a meeting at which a quorum was present with a vote of 1,840.7 FOR; -0-**
17 **AGAINST; 416.1 NOT VOTING; and 160.7 [03] ABSENT, pursuant to the powers vested in the Council**
18 **by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
19 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
20 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
21 **18, 1934 (48 Stat. 984).**
