

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Fiscal Year 2002 Budget for the Tohono O'odham Nation Justice
Branch and Appropriating Funds in the Amount of \$5,454,700.00)

RESOLUTION NO. 01-666

1 **WHEREAS, the fiscal year 2001 ended at midnight, September 30, 2001 and all spending authority**
2 **granted under the 2001 budgets terminated at that time; and**

3 **WHEREAS, to continue operation of the Tohono O'odham Nation it was necessary to grant**
4 **authority to the Nations' government (Executive, Legislative and Judicial Branches)**
5 **to permit the continuance of governmental operations; and**

6 **WHEREAS, the Legislative Council approved Resolution No. 01-454 granting continuing**
7 **authorization for funding governmental operation for the period of October 01, 2001**
8 **through December 31, 2001; and**

9 **WHEREAS, the Judicial Branch of the Nation has prepared and presented a budget to the**
10 **Legislative Council that reflects the needs of the Branch, a copy of the proposed said**
11 **budget is attached hereto and incorporated herein by reference; and**

12 **WHEREAS, the Legislative Judiciary and the Budget and Finance Committees have reviewed this**
13 **budget and recommends its approval and adoption subject to the restriction that**
14 **Judicial Branch salaries shall increase by no more than 20% over the FY 2001 levels.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council of the Tohono O'odham Nation**
16 **has reviewed and hereby approves the Fiscal Year 2002 budget submitted by the**
17 **Judicial Branch provided that no Judicial Branch salaries shall be increased through**
18 **the implementation of market adjustments, longevity steps, and/or any other**
19 **methods by more than 20% over the FY 2001 levels.**

20 **BE IT FURTHER RESOLVED that the Judicial Branch Budget shall be adjusted as necessary to**
21 **comply with the 20% salary increase cap.**

22 **BE IT FURTHER RESOLVED that funds in the amount of \$5,454,700.00 are appropriated**
23 **and authorized to be expended from sources of funding approved by this Council for**
24 **support of the Fiscal Year 2002 budget of the Tohono O'odham Judicial Branch.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST, Day**
26 **of DECEMBER, 2001 at a meeting at which a quorum was present with a vote of 1,435.3 FOR; 982.2**
27 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
28 **Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
29 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat. 984).**
