5 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby**
6 **recognize that the above-named person(s) have relinquished their membership in**
7 **this Nation, and does hereby order that their name(s) be deleted from the**
8 **membership roll.**

9 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH Day**
10 **of JANUARY, 2002 at a meeting at which a quorum was present with a vote of 1,956.75 FOR; -0-**
11 **AGAINST; 115.35 NOT VOTING; and 345.4 [08] ABSENT, pursuant to the powers vested in the Council**
12 **by Article II, Section 3 and Article IV, Section 1 (h) of the Constitution of the Tohono O'Odham**
13 **Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**
14 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16**
15 **of the Act of June 18, 1934 (48 Stat. 984).**
