

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment No. 1 to Attorney Contract with Buescher & Franke, L.L.C.)**


1 **WHEREAS, pursuant to Legislative Council Resolution 01-531, the Nation entered into an**
2 **Attorney Contract with Buescher & Franke, L.L.C. for the purpose of providing legal**
3 **representation to protect the Nation's interests under the Indian Child Welfare Act**
4 **in connection with a legal proceeding in the State of Missouri; and**
5 **WHEREAS, the Attorney Contract was in the amount of \$5,000 for the period from October 1, 2001**
6 **through December 31, 2001; and**
7 **WHEREAS, the Attorney Contract expired on December 31, 2001; and**
8 **WHEREAS, continued representation is necessary to protect the Nation's interests in this**
9 **proceeding; and**
10 **WHEREAS, the Attorney General has proposed Amendment No. 1 to the Attorney Contract which**
11 **extends its term through September 30, 2002; and**
12 **WHEREAS, the Domestic Affairs Committee recommends approval by the Legislative Council of**
13 **Amendment No. 1 to the Attorney Contract.**

14 **NOW THEREFORE, BE IT RESOLVED THAT:**

- 15 **1. The Tohono O'odham Legislative Council hereby approves Amendment No. 1 to**
16 **the Attorney Contract with Buescher & Franke, L.L.C., in the form attached**
17 **hereto, which extends the term through September 30, 2002.**
18 **2. The Chairman of the Nation is authorized and directed to execute Amendment**
19 **No. 1.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH Day**
21 **of JANUARY 2002 at a meeting at which a quorum was present with a vote of 2,273.0 FOR; -0-**
22 **AGAINST; -0- NOT VOTING; and 144.5 [10] ABSENT, pursuant to the powers vested in the Council by**
23 **Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
24 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
26 **18, 1934 (48 Stat. 984).**


