1 **WHEREAS, the Tohono O'odham Nation has successfully operated a program for the elderly**  
2 **members of the Nation; and**

3 **WHEREAS, through Resolution No. 01-616, "Approval of Fiscal Year 2003 Elderly Title VI Program**  
4 **Grant Proposal," the Tohono O'odham Legislative Council approved the project**  
5 **proposal from April 01, 2003 to March 31, 2006; and**


6 **WHEREAS, said dates are incorrect and should read April 01, 2002 to March 31, 2005 as the correct**  
7 **project proposal dates.**

8 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
9 **approves:**

- 10 **1. Amending the project proposal dates to read April 01, 2002 to March 31, 2005 and**  
11 **other items enacted in Resolution No. 01-616 are not effected by this amendment.**

12 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup> Day**  
13 **of JANUARY, 2002 at a meeting at which a quorum was present with a vote of 1,856.9 FOR; -0-**  
14 **AGAINST; 416.1 NOT VOTING; and 144.5 [10] ABSENT, pursuant to the powers vested in the Council**  
15 **by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
16 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
17 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
18 **18, 1934 (48 Stat. 984).**




