

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 01-489, "Approval of the Application and Acceptance
of the Grant Award for the FY 2002 Indian Environmental General Assistance
Program (GAP) Grant")**

RESOLUTION NO. 02-033

1 **WHEREAS, in Resolution No. 01-489, the Tohono O'odham Legislative Council accepted \$125,650**
2 **in new funding for the continuation of the Indian Environmental General Assistance**
3 **Program (GAP); and**

4 **WHEREAS, the GAP Grant project period extends from August 01, 1998 through July 31, 2002; and**

5 **WHEREAS, as part of a continuation grant, the new funding (\$125,650) needs to be added to the**
6 **\$406,148 of existing funds; and**

7 **WHEREAS, Resolution No. 01-489, stated that FY 2001 base salaries will be utilized; and**

8 **WHEREAS, subsequently, the Nation has decided to allow the programs to implement the Valliant**
9 **compensation study recommendations subject to a twenty percent (20%) cap.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby amends**
11 **Resolution No. 01-489 in the following manner:**

- 12 **1. Adding the \$125,650 of new funds to the \$406,148 existing funds for a total budget**
13 **of \$531,798 as described in the attached budget modification #4; and**
- 14 **2. Authorizing the TONEPA to expend all available funds awarded pursuant to**
15 **Cooperative Agreement #GA-98907501 for the entire project period of August 01,**
16 **1998 through July 30, 2002; and**
- 17 **3. Authorizing the TONEPA to use the Valliant compensation study**
18 **recommendations subject to a twenty percent (20%) cap in its FY 2002 budget**
19 **calculations.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
21 **of JANUARY, 2002 at a meeting at which a quorum was present with a vote of 1,662.9 FOR; 499.75**
22 **AGAINST; 254.85 NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**
23 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
24 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
26 **Stat. 984).**


