

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving a Memorandum of Understanding between the Tohono O'odham Nation
and the U.S. Indian Health Service)

RESOLUTION NO. 02-037

1 **WHEREAS, the Tohono O'odham Nation is interested in expanding health services delivery; and**
2 **WHEREAS, the U.S. Indian Health Service has proposed to assign Dr. Charles R. Bridges, a member**
3 **of the Commissioned Corps of the U.S. Public Health Service to position of**
4 **Departmental Diabetes Officer at the Tohono O'odham Department of Human**
5 **Services, for the purpose of providing Dr. Bridges services to the Healthy O'odham**
6 **Promotion Program; and**


7 **WHEREAS, the Tohono O'odham Legislative Council finds that the assignment of Dr. Bridges to**
8 **the Healthy O'odham Promotion Program will be beneficial to the Nation.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
10 **Memorandum of Understanding between the Nation and the U.S. Indian Health**
11 **Service.**

12 **BE IT FURTHER RESOLVED that the Chairman of the Tohono O'odham Nation is authorized and**
13 **directed to execute the attached Memorandum of Understanding with the U.S. Indian**
14 **Health Service.**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
16 **of JANUARY, 2002 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**
17 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**
18 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
19 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
20 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
21 **Stat. 984).**




