

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Attorney Contract with Law Firm of Shelley, Bethea, Gillette & Clark)**

RESOLUTION NO. 02-050

1 WHEREAS, it is advisable that the Human Resources Office has available independent legal
2 representation for employment issues in which the Office of Attorney General is
3 unable to provide legal advice due to conflicts of interest; and

4 WHEREAS, the Human Resources Office recommends an Attorney Contract with the law firm of
5 Shelley, Bethea, Gillette & Clark (the "Attorneys") to provide legal representation to the
6 Human Resources Office for the foregoing purposes; and

7 WHEREAS, the proposed Attorney Contract is in the amount of \$10,500.00 for the period from
8 October 01, 2001 through September 30, 2002; and

9 WHEREAS, the operating budget for the Human Resources Office (Account No. 01-1005-810) for
10 fiscal year 2002 includes sufficient funds for the Attorney Contract; and


11 WHEREAS, the Domestic Affairs Committee and the Human Resources Development Committee
12 recommend approval by the Legislative Council of an Attorney Contract.

13 NOW, THEREFORE, BE IT RESOLVED THAT:

- 14 1. The Tohono O'odham Legislative Council hereby approves an Attorney Contract
15 with the law firm of Shelley, Bethea, Gillette & Clark in the amount of \$10,500.00
16 for the fiscal year ending September 30, 2002 and in the form attached hereto.
- 17 2. Funding for the Attorney Contract in fiscal year 2002 shall be provided under the
18 operating budget of the Human Resources Office (Account No. 01-1005-810).
- 19 3. The Chairman of the Nation is authorized and directed to execute the Attorney
20 Contract.

21 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH Day
22 of FEBRUARY, 2002 at a meeting at which a quorum was present with a vote of 2,042.15 FOR; 375.35
23 AGAINST; -0-NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section
24 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
25 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
26 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
27 Stat. 984).


