15	with the law firm of Shelley, Bethea, Gillette & Clark in the amount of \$10,500.00
16	for the fiscal year ending September 30, 2002 and in the form attached hereto.
17	2. Funding for the Attorney Contract in fiscal year 2002 shall be provided under the
18	operating budget of the Human Resources Office (Account No. 01-1005-810).
19	3. The Chairman of the Nation is authorized and directed to execute the Attorney
