


**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Tohono O'odham Nation's participation in the *Collaborative Longitudinal Evaluation of Ethnicity and Refractive Error Study*)**

**RESOLUTION NO. 02-054**

1 **WHEREAS, the Legislative Council is the governing body of the Tohono O'odham Nation; and**  
2 **WHEREAS, the Legislative Council has always viewed the healthcare and well-being of the**  
3 **children of the Nation as a priority of the Nation; and**  
4 **WHEREAS, the Legislative Council passed Resolution No. 94-264: "Astigmatism and Amblyopia**  
5 **Prevention Project"; and**  
6 **WHEREAS, the children who participated in the "Tohono O'odham Head Start Vision Screening**  
7 **Program" were not eligible to participate in the Astigmatism and Amblyopic Children**  
8 **Project (AACDAT); and**  
9 **WHEREAS, these children are eligible to continue receiving similar benefits by participating in**  
10 **the Collaborative Longitude Evaluation of Ethnicity and Refractive Error (CLEERE);**  
11 **and**  
12 **WHEREAS, it is the recommendation of Human Services Research Committee and the Legislative**  
13 **Oversight committee that the CLEERE Study would provide much benefit for the**  
14 **children of the Tohono O'odham Nation.**  
15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and**  
16 **endorses the Tohono O'odham Nation's participation in the Collaborative Longitude**  
17 **Evaluation of Ethnicity and Refractive Error (CLEERE) study.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup> Day**  
19 **of FEBRUARY, 2002 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-**  
20 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**  
21 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
22 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
23 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
24 **Stat. 984).**




