

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing Kris Kober to the Tohono O'odham Farming Authority Management Board)

RESOLUTION NO. 02-057

1 **WHEREAS, the Second Restated Plan of Operation for the Tohono O'odham Farming Authority**
2 **calls for the appointment of the Directors of the Farming Authority Management**
3 **Board by the Chairman of the Tohono O'odham Nation, with the approval of the**
4 **Legislative Council; and**

5 **WHEREAS, Kris Kober has been nominated to serve as a Professional Representative Director in**
6 **accordance with Section 4.1.3 of the Second Restated Plan of Operation for the**
7 **Tohono O'odham Farming Authority; and**

8 **WHEREAS, the Chairman of the Nation has appointed Mr. Kober to serve as a Professional**
9 **Representative Director in accordance with Section 4.1.3 of the Second Restated Plan**
10 **of Operation for the Tohono O'odham Farming Authority; and**


11 **WHEREAS, Mr. Kober agrees to serve as a Director for that term; and**

12 **WHEREAS, to maintain the proper stagger of terms provided by Section 4.3 of the Second**
13 **Restated Plan of Operation for the Tohono O'odham Farming Authority, Mr. Kober's**
14 **term shall be from the effective date of this Resolution to August 31, 2003.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council approves the appointment of**
16 **Kris Kober to serve as a Professional Representative Director on the Management**
17 **Board of the Tohono O'odham Farming Authority, and that notwithstanding any**
18 **provision of law to the contrary, Mr. Kober's term shall be from the effective date of**
19 **this Resolution to August 31, 2003.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH Day**
22 **of FEBRUARY, 2002 at a meeting at which a quorum was present with a vote of 1,918.15 FOR; 188.3**
23 **AGAINST; 311.05 NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**
24 **Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
25 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
27 **18, 1934 (48 Stat. 984).**




