

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Reappointing Gilbert Two Two to the Tohono O'odham Farming Authority  
Management Board)**

**RESOLUTION NO. 02-058**

1 **WHEREAS, by Resolution No. 99-062, Gilbert Two Two was appointed to the Farming Authority**  
2 **Management Board by the Chairman of the Tohono O'odham Nation, for an initial**  
3 **term of two years in accordance with Sections 4.1.2 and 4.3.1 of the Second Restated**  
4 **Plan of Operation for the Tohono O'odham Farming Authority; and**  
5 **WHEREAS, the Chairman of the Nation has re-appointed Mr. Two Two to serve as the Nation's**  
6 **Representative Director for a term of three years in accordance with Section 4.3 of**  
7 **the Second Restated Plan of Operation for the Tohono O'odham Farming Authority;**  
8 **and**  
9 **WHEREAS, Mr. Two Two agrees to serve as a Director for that term.**  
10 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council approves the appointment of**  
11 **Gilbert Two Two to serve as the Nation's Representative Director on the Management**  
12 **Board of the Tohono O'odham Farming Authority, and that notwithstanding any**  
13 **provision of law to the contrary, Mr. Two Two's term shall be from the effective date**  
14 **of this Resolution to August 31, 2004.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup> Day**  
19 **of FEBRUARY, 2002 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-**  
20 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**  
21 **Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
22 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
24 **18, 1934 (48 Stat. 984).**




