

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Resolution No. 02-058 "Reappointing Gilbert Two Two to the Tohono  
O'odham Farming Authority Management Board")**

RESOLUTION NO. 02-059

1 WHEREAS, by Resolution No. 02-058, reappoints Mr. Gilbert Two Two to the Farming Authority  
2 Management Board for an initial term of two years in accordance with Section 4.1.2  
3 and 4.3.1 of the Second Restated Plan of Operation for the Tohono O'odham Farming  
4 Authority; and

5 WHEREAS, with great discussion the Council determined that the language that is pertaining to  
6 Mr. Two Two's term is not necessary for him to fulfill his appointment to the Farming  
7 Authority Board.

8 NOW, THEREFORE, BE IT RESOLVED that the Resolution No. 02-058 be amended to delete any  
9 language that would pertain to the number of years in his term.

10 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup> Day  
11 of FEBRUARY, 2002 at a meeting at which a quorum was present with a vote of 1,696.2 FOR; 560.60  
12 AGAINST; 160.7 NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by  
13 Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
14 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
15 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
16 18, 1934 (48 Stat. 984).


