

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Setting Special Recall Election for March 9, 2002 for Sif Oidak District Council,  
East Chui Chu Community Representative Maxine H. Norris)**

**RESOLUTION NO. 02-062**

1 **WHEREAS, Article VI, Section 1(g) of the Constitution of the Tohono O'odham Nation delegates**  
2 **the Legislative Council authority "to enact laws and ordinances for conducting and**  
3 **regulating elections"; and**

4 **WHEREAS, the Uniform Election Ordinance ("Election Ordinance"), Ordinance No. 03-86,**  
5 **identifies the Election Board's responsibilities and governs the process for recalling**  
6 **district council representatives; and**


7 **WHEREAS, the Tohono O'odham Election Board has certified Recall Petition #REC-SO-01-02**  
8 **("Petition"), in which East Chui Chu Community voters petitioned for the recall of Sif**  
9 **Oidak District Council, East Chui Chu Community Representative Maxine H. Norris;**  
10 **and**

11 **WHEREAS, pursuant to Article X, Section 9(B), of the Election Ordinance, the Election Board did**  
12 **(1) notify the Legislative Council Chairwoman of the Petition and Board certification**  
13 **on January 30, 2002, (2) file the Petition with the Legislative Secretary on the same**  
14 **date, and (3) request that the Council call a special election within forty (40) days of**  
15 **receiving the Petition.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby calls a**  
17 **special election to be held on March 9, 2002 for the recall of Sif Oidak District Council,**  
18 **East Chui Chu Community Representative Maxine H. Norris.**

19 **BE IT FURTHER RESOLVED that the Tohono O'odham Election Board shall be responsible for**  
20 **conducting the special recall election in accordance with the laws of the Nation.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup> Day**  
22 **of FEBRUARY, 2002 at a meeting at which a quorum was present with a vote of 1,860.65 FOR; 389.55**  
23 **AGAINST; -0- NOT VOTING; and 167.3 [07] ABSENT, pursuant to the powers vested in the Council by**  
24 **Section 1 (g) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
25 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
27 **18, 1934 (48 Stat. 984).**
