| 10 | WHEREAS, | by Resolution 97-478, the Legislative Council approved the transfer of funds from the     |
| 11 |          | Desert Diamond Savings Account to certain designated set-aside accounts                   |

| 13 |          | aside account no. 3030425-1067524 for the Initial Per Capita Distribution (the "Per       |

| 15 | WHEREAS, | three of the conditions to expenditure of the Per Capita Account specified in the FIP     |
| 16 |          | are (1) approval by the Secretary of the Interior of a per capita distribution plan (the  |

| 18 |          | Regulatory Act, 25 U.S.C. § 2710 (b) (3); (2) acceptance by the Legislative Council of a  |
