

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amendment of Resolution No. 01-325, "Approving the FY 2002 for the Title XX - Child Care")

RESOLUTION NO. 02-085

1 **WHEREAS, the Tohono O'odham Legislative Council in Resolution No. 01-325 approved the Title**
2 **XX - Child Care Budget for FY 2002 in the amount of \$127,730.00 for the period of**
3 **October 01, 2001 to September 30, 2002; and**

4 **WHEREAS, the Division of Early Childhood Development has prepared a budget amending FY**
5 **2001 Title XX from \$127,730.00 to \$125,103.00, which reflects the final allocation**
6 **resulting in a decrease in the of \$2,627.00 awarded to the program to be expended**
7 **accordingly; and**

8 **WHEREAS, the Title XX is funded by the State Planned Social Service Block Grant with a Fiscal**
9 **Year of July 01, 2001 to June 30, 2002; and**

10 **WHEREAS, the proper period of operation for FY 2002 funds is July 01, 2001 through June 30,**
11 **2002.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
13 **approve the amended Child Care Services - Title XX Budget for FY 2002 in the amount**
14 **of \$125,103.00 and authorizes the expenditure of funds as described in the State**
15 **Contract.**

16 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby approves**
17 **amending the Fiscal Year reflected in Resolution No. 01-325 from "October 01, 2001**
18 **to September 30, 2002" to "July 01, 2001 to June 30, 2002".**

19 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
20 **Nation's Officials to wit: the Chairman is hereby authorized to negotiate and execute**
21 **the contract, provided however, that any amendments affecting the funding levels of**
22 **the contract shall be submitted for prior approval by this Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH. Day**
25 **of MARCH, 2002 at a meeting at which a quorum was present with a vote of 2,273.0 FOR; -0-**
26 **AGAINST; -0- NOT VOTING; and 144.5 [06] ABSENT, pursuant to the powers vested in the Council by**
27 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
28 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
29 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
30 **Stat. 984).**
