4		general welfare of the Tohono O'odham Nation and its members" (Article VI, Section						
5		1(c)(2), of the Constitution of the Tohono O'odham Nation); and						
6	WHEREAS,	pursuant to Resolution No. 01-470, "Establishing Adult Protection Ordinance Task						
7		Force," the Adult Protection Ordinance Task Force was created and given a goal of						
8		completing an initial draft ordinance by mid-December, 2001; and						
9	WHEREAS,	because the protection of elders and incapacitated adults necessarily involves court						
10		procedures, guardianships, the need for shelter care, and other complex issues, the						
11		Task Force requires additional time to complete its initial draft; and						
12	WHEREAS,	the Legislative Council Health and Human Services Committee has met with the Task						
13		Force and now recommends that the time line set by Resolution No. 01-470 be						
14		extended to provide sufficient time to finish an initial draft of the Tohono O'odham						
15		Nation Adult Protection Ordinance.						
16	NOW, THER	EFORE, BE IT RESOLVED that the Legislative Council hereby amends Resolution						
17		No. 01-470 to give the Adult Protection Ordinance Task Force a goal of completing a						
18		draft ordinance in time for initial review by the Health and Human Services						
19		Committee before the August 2002 Legislative Council General Session.
