RESOLUTION NO. 02-087


1 WHEREAS, the Tohono O'odham Legislative Council has historically supported the Venito Garcia
2 Library and Archives, the library agency of the Tohono O'odham Nation.

3 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts and
4 authorizes the use of funds in the amount of \$5,000.00 from the 2001 Arizona Grants-
5 in-Aid to Tribal Communities to fund the project "O'odham Language CD-ROM
6 Courseware Project" and authorizes the use of these funds for this project by the
7 Venito Garcia Library and Archives, which has made an in-kind contribution of
8 \$12,500.00 on this project, and hereby waives indirect costs which will not be
9 supported by the granting agency.

10 BE IT FINALLY RESOLVED that copyright will remain exclusive ownership of the Tohono O'odham
11 Nation.

12 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH. Day
13 of MARCH, 2002 at a meeting at which a quorum was present with a vote of 2,273.0 FOR; -0-
14 AGAINST; -0- NOT VOTING; and 144.5 [05] ABSENT, pursuant to the powers vested in the Council by
15 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
16 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
17 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
18 Stat. 984).
