**RESOLUTION NO. 02-099**

1 **WHEREAS, the funding amount for the Department of Health and Human Services - Native**  
2 **Employment Works Program Year 2000 is \$150,868.00; and**

3 **WHEREAS, the funding agency has allowed for continual expenditure of funds as long as the**  
4 **expenses are direct program related activities for client program completion; and**

5 **WHEREAS, the administrative budget has been reduced \$2,500.00 and transferred to the Direct**  
6 **Training Budget; and**


7 **WHEREAS, this budget modification extends the expiration date from June 30, 2001 to June 30,**  
8 **2002.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
10 **approve the Department of Health and Human Services - Native Employment Works**  
11 **Program Year 2000 Budget Modification #2 authorized for expenditure from July 01,**  
12 **2000 until June 30, 2002 in the amount of \$150,868.00.**

13 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
14 **Nation's Officials, to wit: the Chairman is hereby authorized to negotiate and execute**  
15 **the contract, provided however, that any amendment affecting the funding or**  
16 **funding levels of this contract shall be submitted for further prior approval by this**  
17 **Council.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup>. Day**  
19 **of MARCH, 2002 at a meeting at which a quorum was present with a vote of 2,232.8 FOR; -0-**  
20 **AGAINST; -0- NOT VOTING; and 184.7 [07] ABSENT, pursuant to the powers vested in the Council by**  
21 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
22 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
23 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
24 **Stat. 984).**


