RESOLUTION NO. 02-101

1 **WHEREAS, the funding amount for the Department of Labor Comprehensive Service Plan**
2 **Program Year 2000 is \$458,356.00; and**


3 **WHEREAS, this budget modification creates the line item capital equipment to purchase**
4 **program vehicles to continue to provide customer service throughout the Tohono**
5 **O'odham Nation.**

6 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
7 **approve the Department of Labor - Comprehensive Service Plan Program Year 2000**
8 **Budget Modification #2 of \$458,356.00.**

9 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
10 **Nation's Officials, to wit: the Chairman is hereby authorized to negotiate and execute**
11 **the contract, provided however, that any amendment affecting the funding or**
12 **funding levels of this contract shall be submitted for further prior approval by this**
13 **Council.**

14 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH Day**
15 **of MARCH, 2002 at a meeting at which a quorum was present with a vote of 2,232.8 FOR; -0-**
16 **AGAINST; -0- NOT VOTING; and 184.7 [06] ABSENT, pursuant to the powers vested in the Council by**
17 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
18 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
19 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
20 **Stat. 984).**
