7		the SAWRSA Trust Fund an amount of \$1,599,730.00 for the second half of FY 1999,
8		\$4,586,219.00 for FY 2000 and \$1,051,458.00 for FY 2001 and \$488,224.35 for FY 2002;

10	WHEREAS,	Modification to the current FY 2002 SAWRSA Trust Fund Budget as attached hereto is
11		necessary to include the additional land subjugation work due to increased
12		quantities of earthwork to be moved at a cost of \$50,000.00 and to accommodate the
13		increase in mileage rates at a cost of \$40.00; and
14	WHEREAS,	the Water Projects Office submitted the attached Budget Modification and
15		justification for the current FY 2002 SAWRSA Trust Fund Budget to continue the scope
16		of work authorized under Resolution No. 99-334 for a total amount of \$538,264.35;

18	WHEREAS,	the Water Projects Office requests from the Tohono O'odham Legislative Council,
19		approval of funding from the SAWRSA Trust Fund to enable completion of tribal
20		responsibilities and obligations related to utilization of Central Arizona Project
21		water and irrigation systems in the eastern Schuk Toak District.
22	NOW, THER	REFORE, BE IT RESOLVED by the Tohono O'odham Legislative Conncil that it hereby
23		approves the funding request and authorizes the additional amount of \$50,040.00 to
24		be added to the already approved FY 2002 budget amount of \$488,224.35 amending
25		Resolution No. 01-513 leaving expenditures in the total amount of \$538,264.35 to
26		complete tasks indicated in the attached budget modification for the fiscal year 2002.
27	BE IT FINA	ALLY RESOLVED that funds in the additional amount of \$50,040.00 are hereby
28		appropriated from the SAWRSA Trust Fund to cover expenditures during the period
29		from October 01, 2001 through September 30, 2002.
