

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Removing Tohono O'odham Ki:ki Association Board Interim Director Dennis Jose)**

**RESOLUTION NO. 02-111**

1 **WHEREAS, the Legislative Council did enact Ordinance No. 98-03, "Establishment of Tohono**  
2 **O'odham Ki:ki Association" ("Ki:ki Association Ordinance"), thereby establishing the**  
3 **Ki:ki Association and its five-member Board of Directors; and**

4 **WHEREAS, Legislative Council Housing Committee members were appointed to serve as Interim**  
5 **Directors on the Ki:ki Association Board only until other individuals could be found**  
6 **to replace them; and**

7 **WHEREAS, four of the five Directors who have been appointed or have a pending appointment**  
8 **to the Ki:ki Association Board are Nation's members who do not serve on the**  
9 **Legislative Council; and**


10 **WHEREAS, these four Directors may establish a quorum, act by majority vote, and otherwise**  
11 **perform the functions of the Board in the absence of a fifth Director; and**

12 **WHEREAS, it is in the Nation's best interests that Legislative Council Representatives no longer**  
13 **serve on the TOKA Board.**

14 **NOW, THEREFORE, BE IT RESOLVED, that the Legislative Council hereby removes Councilman**  
15 **Dennis Jose from the Tohono O'odham Ki:ki Association Board of Directors.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup> Day**  
17 **of MARCH, 2002 at a meeting at which a quorum was present with a vote of 1,308.5 FOR; 756.7**  
18 **AGAINST; 164.0 NOT VOTING; and 188.3 [05] ABSENT, pursuant to the powers vested in the Council**  
19 **by Section 1 (b) and (c)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted**  
20 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
22 **18, 1934 (48 Stat. 984).**




