7 **WHEREAS, the Enrollment Committee has reviewed the application and has recommended that**  
8 **the application be denied because the applicant failed to establish the following**  
9 **membership requirement(s): TOHONO O'ODHAM CONSTITUTION, ARTICLE II,**  
10 **MEMBERSHIP - SECTIONS (1A) and (1B); and**

11 **WHEREAS, the application has come for hearing before this Council; and**

12 **WHEREAS, the Enrollment Committee did serve written notice of its recommendation to reject**  
13 **the application and of this hearing, as required by Section 2, Article VI of the**  
14 **Enrollment Ordinance, upon the person who filed the application and such person**  
15 **was not present at this hearing; and**

16 **WHEREAS, the Tohono O'odham Legislative Council has reviewed all of the evidence presented**  
17 **and from such evidence finds that the applicant has failed to establish the foregoing**  
18 **membership requirement(s).**

19 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby**  
20 **determine that the application of:**

21 James E. Cravens

22 **for enrollment as a member of the Tohono O'odham Nation is hereby rejected.**

23 **BE IT FURTHER RESOLVED that the Chairman of the Tohono O'odham Nation shall issue a**  
24 **certificate of Final Determination of Rejection and that the Enrollment Committee**  
25 **shall serve notice of rejection of the application in accordance with the provisions of**  
26 **Sections 1 and 2, Article VIII of the Enrollment Ordinance.**

5 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
6 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
7 18, 1934 (48 Stat. 984).


