

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of the Tohono O'odham Department of Human Services/Division of Health**  
**Transportation Services FY 2002 Thirty Party Revenue Budget Modification #1)**

RESOLUTION NO. 02-157

1 WHEREAS, the Tohono O'odham Nation is currently providing medically necessary  
2 transportation to members and residents of the Tohono O'odham Nation, collecting  
3 any and all third party reimbursements where applicable; and

4 WHEREAS, there is a need to add a line item for Utilities to the Third Party Revenue budget; and

5 WHEREAS, the Division of Health Transportation Services has modified the FY 2002 Third Party  
6 Revenue Budget to add this line item to cover expenditures for Utilities; and


7 WHEREAS, budget modification #1 has been submitted for review and approval by the  
8 Department of Human Services for the Division of Health Transportation Services.

9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does  
10 hereby approve:

- 11 1. The attached budget modification #1 to the FY 2002 Third Party Revenue Budget.
- 12 2. Establishment of Third Party Revenue Budget line item for Utilities.
- 13 3. The Tohono O'odham Nation officials, to wit, the Chairman and Vice Chairman  
14 and any designated Official is hereby authorized to negotiate and execute the  
15 contract and expend funds associated with this budget.

16 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 02<sup>ND</sup>. Day  
17 of APRIL, 2002 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0- AGAINST;  
18 -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of  
19 Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham  
20 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
21 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


