

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of Tohono O'odham Department of Human Services-Division of
Psychological Services-FY 2002 TODHS TOPS Adolescent Group Budget)**

RESOLUTION NO. 02-158

1 **WHEREAS, the Tohono O'odham Nation is currently operating the Tohono O'odham**
2 **Psychological Services Adolescent Group through a tribal subsidy, and I.H.S. funding**
3 **contract; and**

4 **WHEREAS, the FY 2002 donation of \$1,333.01 was designated for the Adolescent Group; and**

5 **WHEREAS, the TOPS program has prepared the FY 2002 Adolescent Group budget to use the**
6 **donated funds to cover the expenses for the remainder of the fiscal year (February 25,**
7 **2002 to September 30, 2002).**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
9 **approve:**

- 10 **1. The FY 2002 TODHS TOPS Adolescent Group budget at \$1,333.01 to cover expenses**
11 **effective February 25, 2002 through September 30, 2002.**
- 12 **2. That the Department of Human Services requests waiver on Indirect costs for this**
13 **Special donation budget to cover the expenditures for the Adolescent Group.**
- 14 **3. That the Tohono O'odham Nation's Official, to wit: the Chairman, Vice Chairman**
15 **and any designated Officer are hereby authorized to negotiate and execute the**
16 **proposal.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 02ND Day**
18 **of APRIL, 2002 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0- AGAINST;**
19 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**
20 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
21 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
22 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


