

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Resolution No. 01-637 "Approving FY 2002 Budget for the Child Care &  
Development Fund")**

**RESOLUTION NO. 02-162**

1 **WHEREAS, the Tohono O'odham Nation is presently operating the Division of Early Childhood**  
2 **Development for its young members and providing for their welfare through various**  
3 **programs and services designed to meet their special needs; and**

4 **WHEREAS, the Tohono O'odham Legislative Council has approved the Child Care & Development**  
5 **Fund Fiscal Year 2002 Budgets, totaling \$1,082,560.00; and**

6 **WHEREAS, the Department of Health and Human Services, Administration for Children and**  
7 **Families has awarded the Tohono O'odham Nation a Child Care & Development Fund**  
8 **final allocation of \$1,086,128.00 which reflects the actual allocation of \$415,012.00**  
9 **for the Discretionary Fund to implement a Child Care Services Program through the**  
10 **Division of Early Childhood Development; and**

11 **WHEREAS, the Division of Early Childhood Development has submitted a C.C.D.F. Budget**  
12 **Amendment/Modification which reflects an increase in the final allocation of the**  
13 **Discretionary Fund from an estimated amount of \$411,444.00 to \$415,012.00 for a**  
14 **total increase in the amount of \$3,568.00 and also reflects a change in the Indirect**  
15 **Cost Rate from 17.4% to 14.3%.**

16 **NOW , THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
17 **approve amending the Child Care & Development Fund Discretionary budgets for:**

18 **Grant Year 2002 - Mandatory Funds for Administrative Cost in the amount of**  
19 **\$52,958.88 to \$51,560.48 which reflects a decrease of \$1,398.40.**

20 **Grant Year 2002 - Mandatory Funds for Program Cost in the amount of \$618,157.12 to**  
21 **\$619,555.52 which reflects an increase of \$1,398.40.**

22 **Grant Year 2002 - Discretionary Funds for Administrative Cost in the amount of**  
23 **\$75,643.46 to \$73,646.06 which reflects a decrease of \$1,997.40.**

24 **Grant Year 2002 - Discretionary Funds for Program Cost in the amount of \$335,800.54**  
25 **to \$341,365.94 which reflects an increase of \$3,568.00.**

26 **BE IT FURTHER RESOLVED that the duration of this budget would be from October 01, 2001 to**  
27 **September 30, 2002.**

28 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
29 **Nation's Officials to wit: the Chairman is hereby authorized to negotiate and execute**

7 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
8 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
