

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Acknowledging Results of March 9, 2002 Special Recall Election of Sif Oidak District Council, East Chui Chu Community Representative Maxine H. Norris)

RESOLUTION NO. 02-163

1 **WHEREAS, pursuant to Resolution No. 02-062, the Tohono O'odham Legislative Council set March**
2 **9, 2002 as the date for holding the special recall election for Sif Oidak District Council,**
3 **East Chui Chu Community Representative Maxine H. Norris; and**

4 **WHEREAS, the special recall election was conducted by the Election Board on March 9, 2002; and**

5 **WHEREAS, the Election Board has certified (1) that more than thirty percent (30%) of the eligible**
6 **voters registered to vote for such office voted in the recall election, and (2) that the**
7 **incumbent received zero (0) of the eight (8) votes cast; and**

8 **WHEREAS, pursuant to Article X, Section 16(A) and (C) of the Uniform Election Ordinance, an**
9 **incumbent who receives less than a majority of the votes cast in a special recall**
10 **election "shall continue to perform the duties of [her] office until the Certificate of**
11 **Election Results has been officially posted and [her] successor has been certified and**
12 **seated."**

13 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
14 **accepts the Election Board's Certificate of Election Results in the special recall**
15 **election regarding Petition #REC-SO-01-02 and acknowledges that Petition #REC-SO-**
16 **01-02 has passed.**

17 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that, as the incumbent**
18 **Sif Oidak District Council, East Chui Chu Community Representative Maxine H. Norris**
19 **received less than a majority of the votes cast in the Special Recall Election, she "shall**
20 **continue to perform the duties of [her] office until the Certificate of Election Results**
21 **has been officially posted and [her] successor has been certified and seated" (Article**
22 **X, Section 16(C) of the Uniform Election Ordinance).**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03RD Day**
25 **of APRIL, 2002 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0- AGAINST;**
26 **-0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Section 1 (g) of**
27 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
28 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
29 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
