RESOLUTION NO. 02-164

1	WHEREAS, Article VI, Section 1 (g) of the Constitution of the Tohono O'odham Nation empowers
2	the Legislative Council "to enact laws and ordinances for conducting and regulating
3	elections"; and
4	WHEREAS, the Uniform Election Ordinance, Ordinance No. 03-86, identifies the Election Board's
5	${\bf responsibilities and governs the process for recalling district council representatives;}$
6	and
7	WHEREAS, the Tohono O'odham Election Board has certified Recall Petitions #REC-H-01-02 and
8	#REC-H-02-02 ("Petitions"), in which Schuschukigk Community voters petitioned for
9	the recall of Hickiwan District Council, Schuschukigk Community Representative Ron
10	Lewis and Alternate Lenora Montana; and
11	WHEREAS, pursuant to Article X, Section 9 (B), of the Election Ordinance, the Election Board did
12	(1) notify the Legislative Council Chairwoman of the Petitions and Board certification
13	on March 27, 2002, (2) file the Petitions with the Legislative Council Secretary on the
14	same date, and (3) request that the Council call a special election within forty (40) days
15	of receiving the Petitions.
16	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby calls a
17	special election to be held on May 4, 2002 for the recall of Hickiwan District Council,
18	Schuschukigk Community Representative Ron Lewis and Alternate Lenora Montana.
19	BE IT FURTHER RESOLVED that the Tohono O'odham Election Board shall be responsible for
20	conducting the special recall election in accordance with the laws of the Nation.
21 22 23 24 25 26 27	The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the <u>03RD.</u> Day of <u>APRIL, 2002</u> at a meeting at which a quorum was present with a vote of <u>2,417.5</u> FOR; <u>-0-AGAINST; -0-NOT VOTING;</u> and <u>[06]</u> ABSENT, pursuant to the powers vested in the Council by Section 1 (g) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
