9		powers of committees" (Constitution, Article VI, Section 1(a) and (b)); and				
10	WHEREAS,	as a matter of practice, the Legislative Council has appointed a resigning				
11		Representative's successor to that representative's vacant committee seats; and				
12	WHEREAS,	the individual Legislative Committees are empowered to caucus and elect Legislative				
13		Committee Officers (Legislative Rules of the Tohono O'odham Legislative Council,				
14		Article XII, Subsection 3.J.); and				
15	WHEREAS,	Councilman Burrell was elected to the Chairmanship of the Cultural Preservation				
16		and Water Resources Committees; those offices are now vacant due to his				
17		resignation.				
18	NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it hereby					
19		appoints Councilman Crescencio "Tony" Encinas to the Legislative Cultural				
20		Preservation, Housing, and Water Resources Committees.				
21	BE IT FURTHER ORDERED that Legislative Orders No. 01-269, 01-272, and 01-277 (appointing,					
22		respectively, Cultural Preservation, Housing, and Water Resources Committee				
23		members) are hereby superceded only to the extent that Councilman Crescencio				
24		"Tony" Encinas is appointed to former Councilman Burrell's vacated Committee
