


RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Gu-Vo District Fiscal Year (FY) 2002 Budget Modification
and Addition of New Line Item)

RESOLUTION NO. 02-169

1 WHEREAS, the Gu-Vo District Administration presented the FY'02 Budget modification and
2 addition of a new line item to the Gu-Vo District Governing Council; and
3 WHEREAS, the Gu-Vo District Administration requested a new line item be added to the existing
4 FY'02 Budget; and
5 WHEREAS, new line item number 31.7040.860.35 Special Activities in the amount of Six Thousand
6 Two Hundred Eighty-one Dollars (\$6,281.00) to be utilized for the District Clean-Up
7 Day, District Day and other activities held for the District; and
8 WHEREAS, the modification is attached to this resolution.
9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby
10 approves the modification and addition of a new line item in the amount of \$6,281.00
11 to the FY'02 Budget 31.7040.860.35 Special Activities.


12 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04th Day

16 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
17 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
18 Stat. 984).




