8	WHEREAS,	services under the Tohono O'odham Vocational Rehabilitation Program will be
9		provided to eligible American Indians with disabilities who reside on the Tohono
10		O'odham Nation, with enrolled Tohono O'odham members being first priority; and
11	WHEREAS,	the services provided will be consistent with individual strengths, resources,
12		priorities, concerns, abilities, capabilities and informed choice of eligible American
13		Indians so that they may prepare for and engage in gainful employment; and
14	WHEREAS,	a carry forward of \$222,954.03 has been identified from FY-2001 and is being
15		incorporated into the current program budget of \$433,997.00, which will increase the
16		budget to \$656,951.03.
17	NOW, THER	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council supports the FY
18		2002 Tohono O'odham Nation Vocational Rehabilitation Program budget in the
19		amount of \$656,951.03 reflecting carry over funds of \$222,954.03.
20	BE IT FURT	HER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
21		Nation's Officials, to wit: the Chairman is authorized to execute and expend the grant
22		award and provide continued culturally appropriate vocational rehabilitation

24		the funding levels of this grant shall be submitted for further approval.
