RESOLUTION NO. 02-187


1 WHEREAS, the Tohono O'odham Legislative Council has historically supported the Venito Garcia
2 Library and Archives, the library agency of the Tohono O'odham Nation.

3 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council supports the
4 Venito Garcia Library and Archives' grant proposal to the 2002 Rural Arts Project
5 Grant of the Tucson-Pima Arts Council to fund the 2002 Summer Reading Program
6 at the Venito Garcia Library and Archives for the amount of \$1,000.00.

7 BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council accepts and
8 authorizes the use of the provisions of the grant for the Venito Garcia Library and
9 Archives, and waives indirect costs which is a requirement of this particular grant.


10 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH Day
11 of MAY 2002 at a meeting at which a quorum was present with a vote of 1,984.7 FOR; -0- AGAINST;
12 -0- NOT VOTING; and 432.8 [07] ABSENT, pursuant to the powers vested in the Council by Section
13 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
14 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
15 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
16 Stat. 984).


