

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Appointment of Alice Frank to the Board of Trustees for the
Tohono O'odham Community College)

RESOLUTION NO. 02-191

1 **WHEREAS, Resolution 98-06 approved Ordinance 98-01 enacting the Charter of the Tohono**
2 **O'odham Community College (hereinafter "TOCC"); and**

3 **WHEREAS, the Education Committee and the Chairperson of the Nation have recommended a**
4 **candidate for the TOCC Board of Trustees (hereinafter "the TOCC Board"), in**
5 **accordance with Section 4.6.2. of the Charter, and that the candidate recommended**
6 **was forwarded to and reviewed by the Rules and Human Resources Development**
7 **Committees; and**

8 **WHEREAS, Alice Frank meets the minimal qualifications for membership on the TOCC Board**
9 **identified in Article 4, Section 4.6.4. of the TOCC Charter; and**

10 **WHEREAS, the Chairman of the Nation has appointed Alice Frank from the Sif Oidak District to**
11 **membership on the TOCC Board to a term ending May 2004; and**

12 **WHEREAS, the Chairman's appointment has been reviewed by the Rules and Human Resources**
13 **Development Committees of the Council.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
15 **fully confirms and approves the appointment of Alice Frank (Sif Oidak) as a member**
16 **of the TOCC Board to fill one of the four-year terms ending May 2004.**

17 **BE IT FURTHER RESOLVED that Alice Frank shall exercise only those powers established by the**
18 **TOCC Charter for the TOCC Board.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH. Day**
21 **of MAY 2002 at a meeting at which a quorum was present with a vote of 1,329.65 FOR; 995.5**
22 **AGAINST; 92.35 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
23 **Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
24 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
26 **18, 1934 (48 Stat. 984).**
