(Approving FY 2002 Budgets for Child Care & Development Fund for Grant Year  
2001 CCDF Mandatory Administration Cost, CCDF Mandatory Program Cost  
and CCDF Discretionary Program Cost)**

**RESOLUTION NO. 02-201**

1 **WHEREAS, the Tohono O'odham Nation is operating the Division of Early Childhood**  
2 **Development for its young members and providing for their welfare through various**  
3 **programs and services designed to meet their special needs; and**

4 **WHEREAS, the Department of Health and Human Services, Administration for Children and**  
5 **Families has awarded the Tohono O'odham Nation the Child Care & Development**  
6 **Fund for Grant Year 2001 totaling \$960,102.00 to implement Child Care Services**  
7 **through the Division of Early Childhood Development; and**

8 **WHEREAS, the Tohono O'odham Legislative Council is desirous to continue to provide Child Care**  
9 **Services and has approved in Resolution No. 01-380, Grant Year 2001 Mandatory and**  
10 **Discretionary Funds totaling \$960,102.00; and**

11 **WHEREAS, the Child Care Development Fund is a multi-year grant in which Grant Year 2001**  
12 **funds may be obligated by September 30, 2002 and liquidated by September 30, 2003;**  
13 **and**

14 **WHEREAS, the Division of Early Childhood Development has submitted for review and approval**  
15 **the proposed FY 2002 Child Care & Development Fund Budget for Grant Year 2001**  
16 **unobligated funds totaling \$384,857.17.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
18 **approve the FY 2002 Child Care & Development Fund Budgets for:**

- 19 **1. Grant Year 2001 Mandatory Funds for Administrative Cost in the amount of**  
20 **\$20,231.10.**
- 21 **2. Grant Year 2001 Mandatory Funds for Program Cost in the amount of \$207,410.87.**
- 22 **3. Grant Year 2001 Discretionary Funds for Program Cost in the amount of**  
23 **\$157,215.20.**

24 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
25 **Nation's Chairman is hereby authorized to negotiate and execute the grant provided**  
26 **that any amendments affecting the funding or funding levels of this grant shall be**  
27 **submitted for approval by this Council.**


