

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the FY 2002 Budget for the Tohono O'odham Nation Wildland Fire Management Division)**

RESOLUTION NO. 02-228

1 WHEREAS, the Tohono O'odham Nation/Department of Public Safety/Fire Department has taken  
2 over Operations of the P.L. 93-638, Wildland Management from the Bureau of Indian  
3 Affairs to operate the program indefinitely; and

4 WHEREAS, funding has been provided by BIA Wildland P.L. 93-638, and P.L. 106-291 for the  
5 operation of the Wildland Fire Management Division; and will be utilized to provide  
6 emergency services in the saving of lives, property, and protection of natural  
7 resources and wildlife on the Tohono O'odham Nation; and

8 WHEREAS, the Wildland Fire Management Division through P.L. 93-638, Master Contract  
9 #1450CTH54T61071 FY-2002 will contribute \$17,600.00 for the Purchase of a 1,800  
10 gallons up to 2,400 gallon Water Tender vehicle to satisfy matching requirement for  
11 the FEMA grant (Grant No. EMN-2001-FG-04499; and

12 WHEREAS, the Wildland Fire Management Division/Fire Department request approval for FY  
13 2002 budget at \$503,224.00 Base budget, and Indirect cost at \$67,385.03 a total of  
14 \$570,609.03 for the Wildland Fire Management Division.


15 WHEREAS, the request of the approved budget has been reviewed by the appropriate  
16 Committees.

17 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the  
18 FY 2002 Budget for \$570,609.03 for PL-93-638 Wildland Fire Management Division.

19 BE IT FURTHER RESOLVED that the FY 2002 Wildland Fire Management Division's PL-93-638  
20 Budget Funds in the amount of \$17,600.00 will be used as the Nation's 10% match, as  
21 allowed by PL-93-638, section 106(j).

22 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup>. Day  
23 of MAY, 2002 at a meeting at which a quorum was present with a vote of 2,019.45 FOR; -0- AGAINST;  
24 80.35 NOT VOTING; and 317.7[05] ABSENT, pursuant to the powers vested in the Council by Section  
25 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
26 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
27 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
28 Stat. 984).




