

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving 2002 SAWRSA Amendments)**

**RESOLUTION NO. 02-232**

1 **WHEREAS, by Resolution No. 2000-438, the Tohono O'odham Legislative Council approved the**  
2 **introduction in the United States Congress of the Southern Arizona Water Rights**  
3 **Settlement Amendments Act of 2000 (the "2000 Amendments") for the purpose of fully**  
4 **implementing the Southern Arizona Water Rights Settlement Act of 1982; and**

5 **WHEREAS, no action was taken by Congress and the 2000 Amendments are no longer pending;**  
6 **and**

7 **WHEREAS, the SAWRSA Task Force and other major SAWRSA parties prepared an April 30, 2002**  
8 **draft of the Southern Arizona Water Rights Settlement Amendments Act of 2002 (the**  
9 **"2002 Amendments"), a copy of which is attached hereto; and**

10 **WHEREAS, the SAWRSA Task Force, the Chairman of the Nation, the Water Resources Committee,**  
11 **the Schuk Toak District, the San Xavier District and the San Xavier Allottees**  
12 **Association recommend approval of the 2002 Amendments by the Legislative Council.**

13 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 14           **1. The Tohono O'odham Legislative Council approves the introduction in this**  
15 **session of the United States Congress of the 2002 Amendments, in the form**  
16 **attached hereto; provided that the reintroduction of the Amendments in any**  
17 **subsequent session of the United States Congress and delivery as part of the 2002**  
18 **Amendments of the various agreements and documents referred to therein, are**  
19 **subject to further approval of the Legislative Council.**
- 20           **2. The Chairman of the Nation is authorized and directed to deliver the 2002**  
21 **Amendments to Senator Jon Kyl and such other persons who require a copy for**  
22 **purposes of introducing the 2002 Amendments on the terms described above.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15<sup>TH</sup> Day**  
24 **of MAY 2002 at a meeting at which a quorum was present with a vote of 851.45 FOR; 815.8 AGAINST;**  
25 **288.05 NOT VOTING; and 462.2 [06] ABSENT, pursuant to the powers vested in the Council by**  
26 **Section 2 of Article XVII of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
27 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
28 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
29 **Stat. 984).**


