

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 2002 Division of Family Assistance, Food Distribution Program Budget
Modification #1 - Account Number 11-1315)

RESOLUTION NO. 02-251

1 **WHEREAS, the Tohono O'odham Nation, Department of Human Services is presently operating**
2 **the Division of Family Assistance, Food Distribution Program under an FY 2002 Grant**
3 **with the United States Department of Agriculture; and**

4 **WHEREAS, any amendments affecting the funding or funding levels of the grant shall be**
5 **submitted for review and approval by the Tohono O'odham Legislative Council; and**

6 **WHEREAS, the Food Distribution Program has submitted the attached budget modification #1**
7 **for review and approval. The budget modification #1 includes savings of \$4,184.63**
8 **from Indirect Cost of 17.4% to 14.3% effective 10/01/01, and to transfer these funds**
9 **into established line items where additional funds are needed. Also, the re-**
10 **distribution of unexpended funds to line items where expenditures will occur.**

11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 12 **1. It hereby approves and authorizes budget modification #1 increase in the amount**
13 **of \$4,184.63 and authorizes expenditures in accordance with the attached**
14 **budget; and**
- 15 **2. The Tohono O'odham Nation's officials to wit: The Chairman is hereby authorized**
16 **to negotiate and execute the grant.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH Day**
18 **of JUNE, 2002 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0- AGAINST;**
19 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**
20 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
21 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
22 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


