

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(FY 2002 Division of Family Assistance, Low Income Home Energy Assistance**  
**Program Budget Modification #1 - Account Number 12-1310)**

RESOLUTION NO. 02-252

1 WHEREAS, Low Income Home Energy Assistance funds have been made available to the Tohono  
2 O'odham Nation for FY 2002 through the State of Arizona, Department of Commerce;  
3 and

4 WHEREAS, the Tohono O'odham Nation does meet the eligibility requirements to operate a Low  
5 Income Home Energy Assistance Program; and

6 WHEREAS, the Tohono O'odham Nation's application for FY 2002 funding was approved through  
7 the State of Arizona, Department of Commerce in the amount of \$53,980.00 for  
8 contract period July 1, 2001 to June 30, 2002; and

9 WHEREAS, any amendments affecting the funding or funding levels of the contract shall be  
10 submitted for review and approval by the Tohono O'odham Legislative Council; and

11 WHEREAS, the Low Income Home Energy Assistance Program has submitted the attached budget  
12 modification #1 for review and approval. The budget modification #1 includes  
13 savings of \$116.00 from Indirect Cost rate of 17.4% to 14.3% effective 10/01/01 and to  
14 transfer these funds into LIHEAP Payments line item where additional funds will be  
15 dispersed to eligible participants.

16 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:

- 17 1. It hereby approves and authorizes budget modification #1 and authorizes  
18 expenditures in accordance with the attached budget; and
- 19 2. The Tohono O'odham Nation's Officials to wit: the Chairman is hereby authorized  
20 to negotiate and execute the contract.

21 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04<sup>TH</sup> Day  
22 of JUNE, 2002 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0- AGAINST;  
23 -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of  
24 Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham  
25 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
26 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


